1. CALL TO ORDER/ROLL CALL

Nicole Hicks called the Landowner's Election of the Board of Supervisors of the La Collina Community Development District to order on November 15, 2018 at 10:28 a.m.

3. ANNOUNCEMENT OF CANDIDATES/CALL FOR NOMINATIONS

Ms. Hicks announced the candidates: Michael Chris Watson and Brent Dunham.

4. ELECTION OF SUPERVISORS

Mrs. Hicks announced the results: Michael Chris Watson with 8 votes and Brent Dunham with 43 votes. Brent Dunham was elected to Seat 1 with a four-year term.

5. OWNERS REQUESTS

The residents voiced their concerns that not everyone in the community received the ballots and proxies and that the vote should have been delayed. The residents also voiced their opinion that the meetings should be held when more residents are able to attend so the residents have proper representation. The residents also felt that the seat should be held by a member of the community rather than a representative of Homes by Westbay.
